Mindful of the constitution;

Mindful of the law n° 2023/007 of 25 July 2023 on the Higher Education Policy;

Mindful of decree N°2011/408 of 09th December 2011 organising the Government;

Mindful of decree N°2012/433 of 1st April 2012 organising the Ministry of Higher Education;

Mindful of decree N°2012/512 of 12th April 2012 organising the Ministry of Posts and

Telecommunications;

Mindful of decree N° 2016/425 of 26th October 2016 changing the denomination and reorganizing the National Advanced School of Posts and Telecommunications;

Mindful of decree n°2017/594 of 04th December 2017 appointing the Director and the deputy

Director of the National Advanced School of the Posts, Telecommunications and

Information and Communication Technologies;

Mindful of decree N°2019/002 of 04th January 2019 to reshuffle the Government;;

Mindful of order N° 18240028/MINESUP/SG/DAUQ/SDEAC of 14thFebruary 2024, organizing the calendar of competitive entrance examinations into Faculties, Schools and institutions of Cameroon State Universities for 2024-2025 academic year;

On the proposal of the Director of the National Advanced School of Posts, Telecommunications and Information and Communication Technologies.

DECIDE:

ARTICLE 1: Competitive entrance examinations for the recruitment in the first year of Telecommunications Engineers and Administrators of Posts and Telecommunications shall be written on the 03rd and 04th October 2024 at the unique centre of Yaounde.

ARTICLE 2: GENERAL CONDITIONS FOR WRITING

1) Telecommunications Engineers (IT)/Master in Engineering

- Should be male or female, aged 17 at least as from the 1st January 2024;

- Should be holder of Maitrise or Master I in mathematics or physics, Diploma of Assistant Telecommunications Engineers or bachelor degree in Telecommunications, Electronics. Electricity and Computer sciences or any equivalent certificate in above specialities, recognised by the Ministry of Higher Education.
- 2) Administrators of Posts and Telecommunications(APT)/Master in Administration

- Should be male or female, aged 17 at least as from the 1st January 2024;

- Should be holder of Maitrise or Master I, Diploma of Inspectors of Posts and Telecommunications or bachelor degree in Logistic and transport, Accounting and finance, Marketing, Management and administration or any equivalent certificate in above specialities recognised by the Ministry of Higher Education.

ARTICLE 3: NUMBER OF PLACES

The number of places available per cycle is as follow;

1) Telecommunications Engineers:

50 places

- Direct admission for outstanding students of Assistant Telecommunications Engineers of the 2021-2024 batch: 30 places

- Entrance examination:

20 places

2) Administrators of Posts and Telecommunications:

50 places

- Direct admission for outstanding students of Inspectorsof Posts and Telecommunications of

the 2021-2024 batch:

30 places

- Entrance examination:

20 places

ARTICLE 4: CONTENT OF CANDIDATE'S FILE

Candidate's file which must be submitted at the National Advanced School of Posts. Telecommunications and Information and Communication Technologies (SUP'PTIC) of Yaounde, on the 02nd October 2024 for the Cameroonian Candidates and 31st October 2024 for the foreign candidates latest, shall be made up of the following documents:

- An application form to be collected at the National Advanced School of Posts,
Telecommunications and Information and Communication Technologies of Yaounde or in the
the school webside www.e-supptic.cm;

- A payment receipt to any post office, account number 150657330-19 of 25,000 CFAFrs.

- A certified true copy of birth certificate not more than 03 months old from the date of certification;

A certified true copy of the required certificate;

- Transcripts for the last three or four years spent in the University or a Higher Institution;

- A school attendance certificate for candidates still expecting the results of the required certificate;

- A medical certificate of fitness for working in the Posts and telecommunications sector, issued by a public medical practitioner;

- Two (02) passport size photographs (4x4);

- A certified true copy of the National Identity card;

- A self-addressed stamped (Postal Stamp) envelope(1000 FCFA)

- Eventually the equivalent of the diploma presented.

ARTICLE 10: The results of the examinations shall be published by a communique of the Minister of Higher Education and the Minister of Posts and Telecommunications.

ARTICLE 11: Foreign students shall sit for special examinations organised by the Director of the National Advanced School of Posts Telecommunications and Information and Communication Technologies in collaboration with the concerned countries.

ARTICLE 12: Candidates presented by the public and para-statal and/or private organisations fulfilling the general conditions for the competitive entrance examination shall be authorised to write the exams.

ARTICLE 13: At the end of their training, outstanding students at Master's level will benefit for scholarships at the Doctorate program.

ARTICLE 14: The Director of the National Advanced School of Posts, Telecommunications and Information and Communication Technologies and the Director for University Accreditations and Quality are each in his capacity, responsible for the implementation of this decision, which shall be registered, published and broadcast wherever need be./-
